▶ CENSUS DATA AND REDISTRICTING
EDUCATION CODE SECTION 1002

- After every Census, a County Committee shall adjust the trustee areas for their respective County Board of Education, which involves:
 1. Review of population data to determine if voting areas are still within the allowable variance
 2. Make any necessary adjustments to the areas to ensure population balance within legal requirements
- Typically, the data required is released by March 31 of the year following the Census
- Changes to voting areas need to be filed with the registrars of voters for the counties served by the Board of Education in advance of the November 2022 election. County offices of education have a deadline of **February 28, 2022**



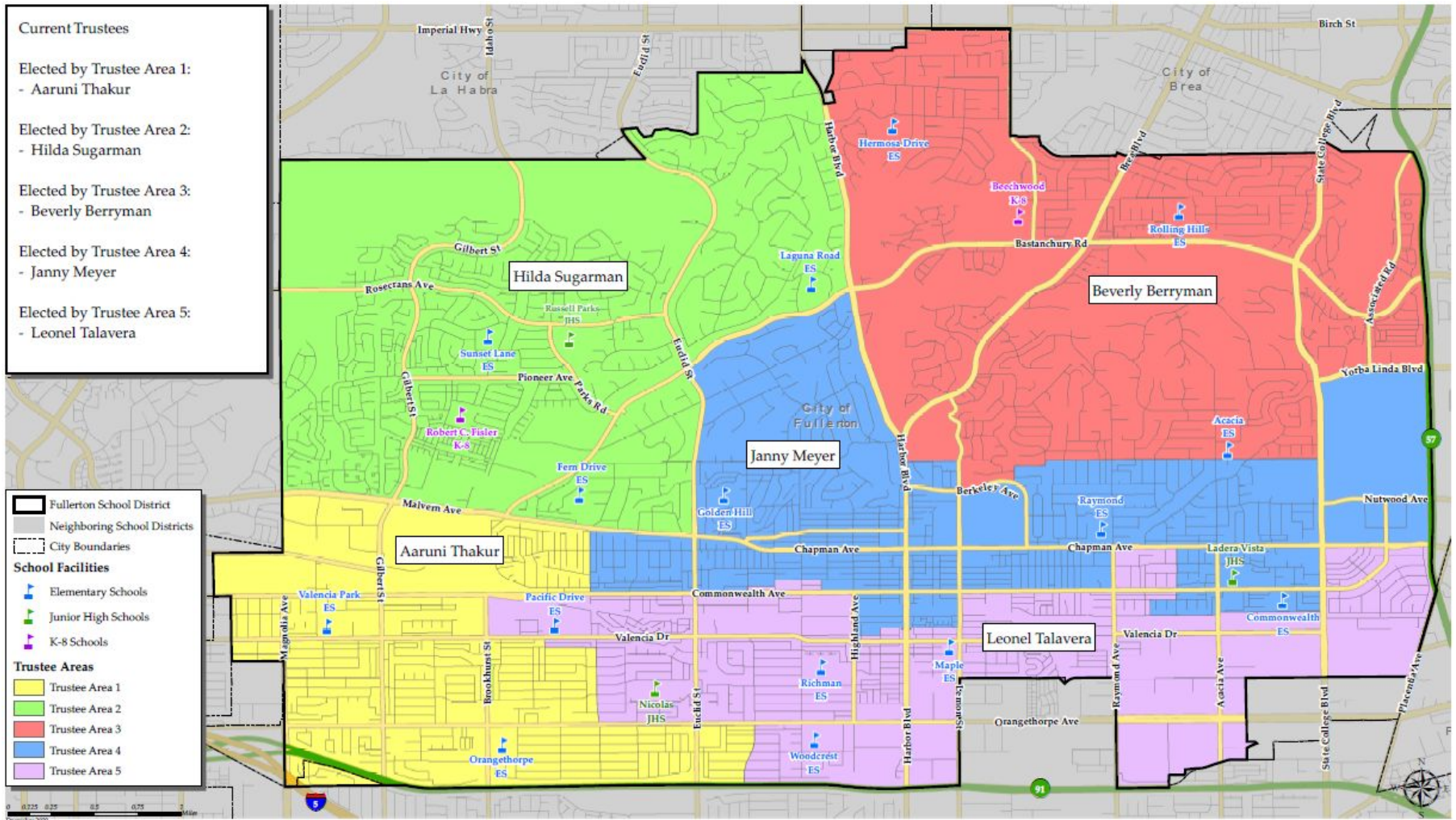
▶ CENSUS DATA AND REDISTRICTING

TIMING OF DATA

- Release of 2020 Census data has been delayed due to the COVID-19 pandemic
- Census data at the block level was released August 12; the data will first be validated by the Department of Finance and be made available by the end of September
- Compresses timeframe for public agencies who elect by-area to review and adjust their voting areas
- Potential for legislative changes, including changes to primary election date
- No formal process in statute governing the process to adjust trustee areas following each Census

► CONSIDERATIONS IN TRUSTEE AREAS



Each area shall contain nearly equal number of inhabitants



Follow man-made and natural geographic features, as much as possible



Drawn to comply with the Federal Voting Rights Act



Respect incumbency, if possible



Compact and contiguous, as much as possible



Other local considerations (i.e., school boundaries, locations of school sites)



Respect communities of interest, as much as possible

October 13 th – November 9 th	Cooperative Strategies prepares potential maps of adjusted Voting Areas
November 10, 2021	Draft Maps posted to Fullerton SD website
November 16, 2021	Board Meeting: Review Initial Scenarios
November 17 th – December 5 th	Cooperative Strategies revises scenarios based on Board and Public Input
December 6, 2021	Draft Maps posted to Fullerton SD website
December 14, 2021	Board Meeting: Review Maps and Conduct Public Hearing Board Selection of Map
January 2022	Cooperative Strategies sends Final Trustee Area Map and Descriptions to the County Registrars of Voters
